This resulted in the systematic genocide of Turtle Islands first people followed by generations of oppressive views and systemic barriers still perpetuated to this day.

We understand that in order to truly begin working towards the ideals of D E I then we must ensure that creating an Oxford where Indigenous people along with other minority groups can also feel they belong is our number one priority as a committee, this is a paramount step towards Reconciliation itself.

We can begin to honor and respect inclusion by exploring the concepts of the seven grandfather teachings of the Anishinaabe people, incorporating their intentions into our work. - Love, Respect, Courage, Wisdom, Honesty and Truth.

We can promote equity by learning more about the history and intentions of the treaties of our area and work towards diversity by increasing consultation and collaboration with Indigenous Peoples and organizations to demonstrate being good treaty partners. We can also do our best to address the calls to actions for Municipalities put forth in the TRC.
