6. Discussion Items:

- I. One of Oxford County's Strategic Plan's goals is to have a Climate Action Plan. Chelsea Martin seeks the Coalition's members' perspectives on the effects of climate change on equity-seeking groups.
 - a. Chelsea presented how DEI and the Climate Action Plan intersect and are part of the early stages of the Plan.
 - b. How can this committee support? Looking for feedback from a DEI lens.
 - c. Lower-income housing, growing food-bearing trees/plants in these areas, helps with food insecurity, and flooding often happens in these homes due to vegetation removal. Using native plants, as this is their natural biome.

- d. This information is currently only available for Woodstock. It would be helpful to get similar information for other communities in the area.
- e. Will there be an opportunity to have further conversations about this? Chelsea would like to present the Plan to the Committee again once she has a draft. An online survey will be distributed to the community on June 1st
- f. How is this information distributed to non-English speakers? Leila does not find that the Muslim community seeks out this information. Chelsea will take it away and think of strategies to do that.
- g. Patricia suggested a storyboard walk as an educational opportunity.
- h. Ensure we reach out to the rural populations, as we have one of the largest rural areas in SW Ontario engage 4H clubs.
- i. Infographic-type materials Leila can send them out to Muslim groups. Can also arrange a presentation/activity at the mosque. Involve the kids.
- j. Chelsea can share communication materials with Julie and Ayesha, who can assist with sharing the information.
- k. Address misinformation and gaps.

 - DEI and Human Rights Postcard draft.
