## 6. Discussion Items:

- I. One of Oxford County's Strategic Plan goals is to have a Climate Action Plan. Chelsea Martin seeks the Coalition's members' perspectives on the effects of climate change on equity-seeking groups.
  - Ayesha updated that Chelsea was not feeling well and would attend our next meeting.
- II. Discuss goals/priorities- Education & Awareness:
  - a.DEI and Human Rights (Postcard draft attached)
  - Ayesha shared her and Tajay's postcard drafts to show what it would look like with the information added to a card.

- Joanna's feedback on Ayesha's draft was creating an infographic with less information and suggesting simpler graphics. Joanna added that the postcard Tajay created was quicker to read; however, she suggested shorter bullets and simplified language.
- Ayesha suggested changing the image on Tajay's postcard.
- Leila suggested adding a QR code that could be scanned for additional information and less information on Ayesha's and Tajay's drafts.
- Patricia suggested a change in the font on the postcard created by Tajay.
- Tajay suggested changing the language in the chart from the word "demanding."
- Action: Ayesha will run both drafts by Pauline, Tammy, and Amy and work on revising the language.
- Patricia suggested the group consider the systems level vs. citizens level and further suggested adding a slogan, "We've got you covered."
- Tajay added to Patricia's point about considering the "citizen level" and suggested adding an umbrella image for people to understand the terms listed better.

b. Which significant days do the Committee members want to recognize that could help shape specific targeted education or events for this year and next & why?

- Ayesha shared that she has been sent the significant days committee
  members would like to be added to the calendar; however, she suggested
  narrowing things down to focus on the specific education target. Ayesha
  shared a sample calendar that would be used as a guiding document.
  Ayesha will send a final version of the calendar again for members to
  review, select days to write educational content, and post that day.
- c. The Committee can also work on developing educational materials on issues highlighted in the Safe and Well Oxford Community Safety & Well-being Plan, e.g., racial issues, racial inclusion in schools, human rights, etc.
